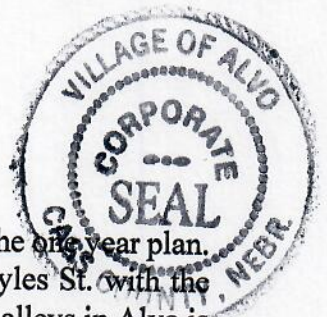

CDBG grant funds in the amount of 345,000 were discussed in detail for the one year plan. This would be a asphalt overlay of Fletcher Ave. from Russel St. to Boyles St. with the village being required to pledge in writing a 10% match. Rerocking of all alleys in Alvo is discussed in detail for the six-year plan. Vice Chairperson Cathina Schueth reads the required Municipal Annual Certification of Program Compliance to Nebraska Board of Public Roads Classifications and Standards 2024 to the public, known as Resolution No. 2024-003.
