- NDOT has provided notice that roundabout at US-34/N-50 junction in Cass County is tentatively scheduled for 2027.
- 2025 1st Quarter Combined Tax Report and Wage Report provided to Department of Labor, NDOL. NDOL will need Mike Lanctot and Hunter Long's personal information in order to complete forms for the village.

Quarter Combined Tax Report-

Purpose: Reports the total gross wages paid during the quarter and calculates the unemployment insurance tax due.

Details: Employers must submit this form each calendar quarter, regardless of whether any wages were paid during that period. The form includes information such as the employer's tax account number, federal identification number, total gross wages, and the calculated tax amount due.

Wage report-

Purpose: Provides detailed wage information for each employee.

Details: This form requires the reporting of each employee's Social Security number, name, and gross wages paid during the quarter. Employers should include wages paid under 401 (k) plans but exclude those under Section 125 Cafeteria plans. Additionally, while optional, employers may report the total number of hours paid (including regular, Vacation, and sick time) and the primary job title for each worker.

• Village has completed 2024 Annual 941N withholding form and Sales and Use Tax form to the Nebraska Department of Revenue.

Met over the phone to start the process to obtain information needed to move forward with NDOR on 5/13/2025. Will require letter with board members name, positions, and titles as well as clerk/treasures. NDOR will assist with filling, there will be penalties for filing after the 2025 1st Quarter deadline.

Sales and Use Tax-

Purpose:

This form is used to report and remit sales and use taxes collected on taxable transitions, such as retail sales, leases, or rentals of tangible personal property and certain services.

941N - Income Tax Withholding Return

Purpose:

Form 941N is used to report Nebraska state income taxes withheld from employees' wages. Employers must file this form to reconcile the amount of tax withheld and remitted to the state.
